John's grandfather died in December 1826:

Last week, Peter Roberts, of Parkgate, boatman, in the employ of Mr Ball. He was well known and respected as an intrepid sailor and an industrious and honest man.¹

The following year, his father, also called Peter Roberts, married:

On Wednesday last, at St. James's Church, Mr Peter Roberts, jun., sail-maker, Upper Parliament-street, to Miss Eliz. Howard, Toxteth-park.² On the church register, the marriage was by licence on 13 June 1827, and both signed their names. They also married on 26 June 1827 at the Catholic Church in Liverpool. The witnesses were Mrs Roberts and Richard Wade.³ (Richard Wade was married to Mary Robert's sister Ellen)

Then, in 1828, this advertisement appeared in the newspaper. $^{\rm 4}$

<u>Note</u>: There is more than one Peter Roberts sailmaker in Liverpool. NOTICE is hereby given, that the Business carried on by the late PETER ROBERTS, Sail-maker, No. 36, Salthouse Dock, will in future be carried on by his Widow, in Partnership with her son Perzer Rossers, under the firm of "MARY HOBERTS and SON," on the above Premises, where all Orders will be thankfully received and punctually situnded to. All debts due to and owing by the late Peter Roberts, will be thankfully received and paid by Bacs. Wane, Park-lane. Literpool, May 17, 1823.

It seems John Roberts' real name is Peter Howard Roberts.⁵

On 12 July 1830, an advertisement announced the partnership between Mary Roberts and her son Peter Roberts, Liverpool, sail-makers, has been dissolved.⁶

John's mother died between 1839 and 1841. In 1841, the family lived with John's grandmother at Summer Gardens, Walton on the Hill, West Derby, Lancashire:

John's father re-married on 1 November 1841 at St Philip Church, Liverpool:

Peter Roberts, full age, widower, sail-maker, and his father Peter Roberts, a sail-maker. Jane Holland, full age, spinster, daughter of John Holland, a plasterer.

On the 1851 census, Peter Roberts was a proprietor of houses. His youngest daughter, Ann from his first marriage, was living with them in West Derby, Liverpool.

Another child, Agnes Augusta, was born in 1851. Then in 1853, the family, Peter, Jane and their children migrated to Victoria, leaving on 23 July 1853, per *Goldfinder*, and arriving on 23 October. Peter is listed as a Grocer. Jane gave birth to Atalanta during the voyage; perhaps she was born in the Atlantic Ocean. She died aged eight months, in March 1854.

Jane Roberts died on 8 July 1854 of general dropsy and effusion of the chest, aged 39. The family had been in Victoria for eight months and stayed in Victoria.

On the 17th May, at Melbourne, Australia, aged 37, ELLEN, wife of Mr. MICHAEL HEALY, and youngest daughter of the late Mr. Peter Roberts, sailmaker, of this town; also, on the 16th June, aged 36, Mr. MICHAEL HEALY, husband of the above, and late of Dublin; and, on the 7th July, aged 38, JANE, wife of Mr. PETER ROBERTS, sailmaker, late of this town, second daughter of Mr. John Holland, Everton Village, and sister-in-law to the above.

Peter Howard Roberts becomes John Roberts:

In February 1848:

Daring shop robbery.— On Wednesday afternoon, three young men named John Dixon, **John Roberts** and George Butler went into the shop of Mr Sach, baker, of Kelvedon, and asked for some bread. Mr Sach was at home, and the lad behind the counter, William Potter, told them it did not lie in his power to comply with their request, whereupon one of them deliberately took the loaf from the window which broke and distributed to his companions. The boy called his mistress, who came into the shop, and he went for a neighbour. After he was gone, the prisoners remained in the shop for about ten minutes, during which they ate the bread and then decamped. They were, however, overtaken and apprehended at Rivenhall by police constable Varnham and were yesterday morning brought before W. W. Luard Esq. at Mr Blood's office, at Witham, by whom they were committed for trial at the adjourned sessions.⁸

At the Essex County Adjourned Sessions, on 15 February 1848:

George Butler, 20, John Roberts, 21 and John Dixon, 23, were convicted of larceny and sentenced to 7 days and whipped.⁹

The following month, at the Home Circuit, Chelmsford, on 10 March 1848:

John Roberts, 21, Thomas Folks 17, and George Butler, 20, three miserable-looking lads, were indicted for a burglary in the dwelling-house of Lucy Marshall and stealing some silver money and other articles, her property.

Mr Glyn prosecuted. It appeared that the prosecutrix is a widow, and she occupied, with her sister, a cottage in a lonely position near the village of Stansted, Mountfitchet. In the dead of the night of 25 February, she was awoken by hearing a noise in her sister's bedroom, and, upon going to see what was the matter, she found her sister in bed in & a state of great alarm. The prisoners, Folks and Roberts, were in the room, the former with a large dinner knife in his hand. When they saw the prosecutrix, they demanded her money and took away a pocket containing about seven shillings. They then asked for "grub," and regaled themselves with some food, and drank a bottle of homemade wine, after which they told the prosecutor to

go to bed again, threatening her with violence if she gave any alarm, and they said they should leave a "watcher" outside to see if she disobeyed their injunctions.

The prisoners then went away but were apprehended shortly afterwards with part of the stolen property in their possession. It appeared pretty clear that Butler was outside the cottage watching, as they stated, while the others were committing the robbery. The prisoners were found Guilty, and Roberts and Butler, who had been before convicted of a felony, were sentenced to be transported for fifteen years, and Folks was ordered to be kept to hard labour for eighteen months.¹⁰

The following convicts were on Saturday removed from the Convict Gaol, Springfield, to Millbank Penitentiary —For fifteen years. John Roberts and George

Butler, for burglary at Stansted Mountfitchet.^{11, 12} John Roberts, 21, single, can read and write, labourer, was

convicted on 6 March 1848 at Chelmsford of burglary after a

previous conviction and sentenced to 15 years transportation. Once previously convicted and whipped. He was received at Millbank prison on 1 April 1848 from Springfield Prison in Essex. Eight months later, John was transferred to Pentonville Prison on 9 December 1848.¹³ He was received at Pentonville prison on the same day. At Pentonville, his age was 22, and his occupation was a Gentleman's servant. The Pentonville Prison register mentions his real name, Peter.

He was removed to Portland Prison on 9 December 1849.¹⁴ From Portland Prison, he boarded the *Hashemy* on 19 July 1850 for the voyage to Fremantle. George Butler, convicted with John, was also on the *Hashemy*. On arrival at Fremantle, his description was:

153. John Roberts, 20, 5' 6", brown hair, hazel eyes, thin face, dark complexion, scar on right shin, servant and single. ¹⁵

General Register:

153. John Roberts, 21, single, Gentleman's servant, Church of England, private school, read pretty well, read tolerably and fair with numbers. His father, Peter Roberts, sail-maker, lives in Bootle near Liverpool.

John received his Ticket of Leave on 10 <u>August</u> 1851.¹⁸ Another record says he was discharged to Ticket of leave on 10 <u>September</u> 1851. Two other entries on 15 and 24 September may also refer to him.¹⁹ On 28 September 1851, he was given a pass to Fremantle.²⁰

Later in the year, on 17 December 1851:

The undermentioned were forwarded by Glyde's Boat to Toodyay this day, viz:

Reg. No. 153 John Roberts from Hospital, 66 John Bradbury and 67 John Morris.

The two former go to Toodyay Station and Mr Syred at the Half Way House, Toodyay.²¹

The following is possibly John Roberts 153, although John Roberts 613 also had a ticket of leave. Fremantle, 26 July 1852—John Roberts, ticket-of-leave holder, charged with talking to prisoners while at work, and keeping them idle; and with being insolent to the warder in charge, when told not to do so; admonished, and fined 20s and costs.²²

At Fremantle, on 4 September 1852:

John Roberts, charged by John Duffield with having taken some timber from his grant without permission. From the evidence given by George Dixon, the employer of Roberts, it appeared he had permission from Duffield to take 6 loads, and that only one load had been taken without leave; ordered to pay compensation and expenses; in all, £1 16s 6d. ²³

On 20 September 1852, at Fremantle, John Roberts, 153, t.l., charged with calling John Duffield a rogue, and using improper and abusive language to him in the streets of Fremantle; several witnesses were

examined, alter which, Roberts was admonished, and informed that a repetition of such conduct would ensure his return to the Convict Establishment, and the case dismissed.²⁴

John was granted a Conditional Pardon on 13 August 1859.²⁵

John Roberts changes his name back to his real name, Peter Howard Roberts.

Peter Howard Roberts married Elizabeth Tonkin on 28 February 1860 at Fremantle. She was the daughter

of John Foss Tonkin. They did not have had any children. In February 1865, P Roberts was elected to the committee

of the Western Australian Working Men's Association.²⁶

From 1869 to 1875, a P Roberts, Storeman, Fremantle, is listed in the Directory: People in the Colony of Western Australia 1863-1897.27

July 1868: Fremantle Union Benefit Society. Peter N Roberts on the committee to enrol members.²⁸

An Eating and Boarding House Licence was granted to Peter H Roberts by the Fremantle Court on 6 December 1875.²⁹ He held the licence until 1884.

His brother William was a publican in Cheshire.

1885. After Peter's death, the boarding house became ...

1887. H. C. Barnett v. Elizabeth Roberts. — Mr H. Parker appeared for defendant. The claim was for medical attendance; Mr Parker contended that the defendant, being a widow, was not responsible for her late husband's debts, and he therefore asked for a nonsuit, which was allowed, with costs.³¹

..... In the course of the hearing it transpired that the summons was serve upon her while driving to her wedding.32
